I, on behalf of myself, heirs, beneficiaries, assign, agents, child or children, wards, and conservatees, or any or all of them, do hereby release and discharge RCWC and Peggy Hentz, together with the assignees, directors, officers, agents, employees, members, officials, heirs, or any or all of them and their successors, from any and all incidental, or indirect, special or, consequential damages, including but not limited to, the loss of salary or wages or loss of opportunities, of whatsoever nature or kind arising out of, as a result of, or in connection with said volunteer activities occurring on premises under the control of RCWC.

This Release of Liability contains the entire agreement between RCWC and myself and supersedes any previous understanding, commitments, or agreements (oral or written) with respect to the subject matter hereof. This Release of Liability and interpretation thereof shall be governed by the laws of the State of Pennsylvania.
